

The Hume Youth Commitment (HYC) 3-year Action Plan (2023-2025) has been developed to align with the HYC Spirit of Cooperation Agreement renewed in 2023 for a 3-year period. The HYC operates as part of the governance structure for the Hume Whittlesea Local Learning & Employment Network (HWLLEN) within the Hume LGA. HWLLEN funds the staffing to facilitate the oversight of HYC operations and development of partnership collaborations.

Vision Statement

The Hume Youth Commitment is committed to providing young people in the Hume LGA the support required to enable inclusive access to engage in education, training and employment.

Statement of purpose/aims

The Hume Youth Commitment (HYC) aims to:

- provide a collaborative platform for local organisations, businesses, education providers, community groups, and government departments to explore ways of working together to enhance young people's access to education, training and employment.
- address identified needs and barriers for vulnerable young people which impact their access to education, training and employment.
- enhance school industry engagement and career pathway development by encouraging and brokering partnerships which will provide additional supports.
- further support the key transition points for young people (e.g., primary to secondary school and secondary to further study, training and employment).
- advocate for services and facilities that provide improved access and support for young people in Hume.

Objectives

The objectives for the HYC are to:

- Facilitate a platform for local organisations, businesses, education providers, community groups, and government departments to share inclusive education, training and employment opportunities appropriate to the needs of young people in the Hume LGA.
- Provide opportunities for the sharing and disseminating of updated information which impacts education, training and employment policies, procedures and practices relevant to the needs of young people.
- Act as a conduit for providing access to key stakeholders working to support outcomes for young people for the purpose of knowledge sharing and development of potential collaborations.
- Support young people's transition from secondary school to further study, training and employment by providing initiatives which improve their access and awareness of career pathway opportunities.
- Work in collaboration with other networks and initiatives operating in Hume, such as the Community Investment Committee, to support outcomes for young people.
- Advocate for additional support to further enhance transition programs from primary to secondary school.
- Support collaboration with stakeholders to develop and implement programs/projects that support the needs of young people to overcome barriers to education, training and employment.



- Improve local connections between schools, community and industry to increase awareness of future employment options and to further develop employability skills.
- Promote the importance and benefits of year 12 completion with a focus on supporting school retention.

Evidence informed actions.

The HYC aims to identify needs relating to young people's access to education, training, and employment as identified through current and emerging trends noted through the stakeholder networks (HYC and HYC Supporters Strategic Advisory Group).

The HYC's evidence informed approach is supported by relevant data sourced from various local, regional, and statewide data sets such as:

- Hume Human Services Needs Analysis
- Hume City Council demographic, employment, and industry data
